**TENDER TERMS & CONDITIONS FOR PURCHASE OF NEW JUTE GUNNY BAGS**

1. **ISI marking:** Only ISI mark jute gunny bags of size as per BIS marked confirming to IS No. 16186:2014 can be offered. No seller is allowed to offer non BIS marked bags. The sellers will provide the jute bags without stencils.
2. **Delivery period:** Standard delivery period for jute gunny bags shall be 20 days. Otherwise earnest money deposited will be forfeited. Sellers may be asked to supply more quantity, if necessary. The sellers will deliver at consignee location on free delivery i.e. FOR delivery. PAIC may reserve the right to increase or decrease the volume of order at any stage.
3. **Terms of delivery:** free delivery at sites including loading/unloading.
4. **Octroi duty / other local taxes:** The contact price/ offered price are all inclusive. Hence no reimbursement over and above the offered price shall be allowed to seller towards payment of local taxes (such as levy of town duty, octroi duty, terminal tax and other levies of local bodies etc.)
5. Bidders are required to quote their best possible price within the stipulated delivery period at the consignee location.
6. After technical evaluation, PAIC would open the price bid / financial bid of technically qualified bidder and do financial evaluation of bids and decide the reasonable price that they find acceptable.
7. 50 kg jute gunny bags received which are not in conformity with the specification will be rejected. In case of rejection, the supplier will replace the bags immediately from the date of intimation.
8. The bidders are required to submit earnest money deposit (EMD) of Rs. 1,00,000/- alongwith tender form fee.
9. The payment of the purchase gunny bags to the bidder will be made after receiving of the whole quantity and after receiving satisfactory report from the committee formed for inspection.
10. The refund of EMD to the unsuccessful bidder will be made only through RTGS within period of two weeks and no interest will be paid on the same.
11. The bags should not be highly gracy and free from chemicals to avoid any germination damage to seeds.
12. Joint inspection of 25 % jute bags of total received bales will be carried out and if any bales found below the specifications, the same shall be rejected and be replaced by the supplier.
